- 1. <u>Policy Statement:</u> The responsibility of the Board of Directors is to protect the association's interests while providing safe effective service & support.
- 2. <u>Reason for Policy:</u> The ownership of dangerous breeds and the possibility of association liability when allowed to be owned or housed on the complex.
- 3. <u>Who Should Read this Policy</u>: All Villas of Wesburn Association members should read and be knowledgeable of this, and all policies regarding these premises.
- 4. Resources: None
- 5. <u>Definitions:</u> The following animal breeds are governed by this policy:
 - a. A breed commonly known as a Pit Bull Terrier, either an American Straffordshire Terrier, a Straffordshire Bull Terrier or an American Pit Bull Terrier, registered or nonregistered, or of any dog of a mixed or crossbreed with any of such breeds.
 - b. Any animal that has shown a tendency toward being dangerous as determined by the Board.
- 6. <u>The Policy:</u> The following controls are placed on the owner of the above breeds and animals designated dangerous by their actions:
 - a. Must be eighteen years of age or older and the only public handler of the animal.

- b. The owner must carry a \$1,000,000 liability rider specifically covering animal attacks.
- c. Provide information, including the name, address, telephone number, city and county, from whom or where the owner acquired such dog.
- d. Notify the South Rockwood Animal Control and the Villas of Wesburn Association within a twenty-four hour period when the owner has knowledge that such dog is at large, unconfined, has attacked an individual or has died.
- e. Notify the South Rockwood Animal Control and the Villas of Wesburn Association within a twenty-four hour period when such dog is sold or given away to another person. The notification shall include the name, address, telephone number and city of the new owner.
- f. Shall keep such dog on a leash and muzzled at all times when not within the owner's unit. Garages, decks, porches and patios are not considered being inside the owner's unit.
